NOTIFICATION

It is for general information of all concerned that the Government of Assam has ordered a 'Lockdown' across the State with effect from 1800 hours on 24th March, 2020 to 2400 hours on 31st March, 2020, as precautionary restrictions to prevent and contain rapid spread of Corona Virus.

Accordingly, all activities of Assam Agricultural University, other than the essential ones, shall remain suspended while maintaining all possible social distancing and isolation measures. The essential services shall include--

1. Medical Services
2. Power and Water Supply
3. Internet Services (ARIS cell)
4. Livestock farms & Agri-Horti farms requiring critical inputs
5. Security and Conservancy services
6. Services under IMD (Gramin Krishi Mausam Seva)

Also, considering the financial year-end in view, the persons relating to finance/clearing of bills, not exceeding 5 in number, including the DDOs shall complete their jobs at the earliest. Respective controlling officers shall plan and ensure smooth sailing of the emergency services, while maintain the highest degree of personal/public hygiene in the public interest.

The Controlling Officers will also prepare list of employees who are required for maintain the essential duties or relating to finance/accounts and issue order accordingly for attending the duties, as and when required, during the lockdown period.

The "Complete Safety Restrictions", as notified by the Government of Assam vide notification No. HLA 248/2020/35 Dated Dispur the 23rd March, 2020 shall remain operative for the entire period.

The earlier order on arrangement of employees requiring to attend office in alternate weeks stands cancelled.
