- 3) The selection and appointment will be made by a Screening Committee constituted by the Incubator for this purpose. Some of the junior level positions may have a two-stage selection process. Only shortlisted candidates for any of the positions will be intimated through email for attending an interview for final selection.
- 4) The age limit, qualifications, experience and other requirements may be relaxed at the discretion of the Screening Committee, in case of deserving candidates.
- 5) The appointment will be initially for a period of one year which may be extended based on a satisfactory performance evaluation at the end of the first year. The positions are presently under project mode and will be co-terminus with the project.
